Explanatory Notes to the Statement of Compliance with CPD and RME Requirements – Solicitors

Note 1:

There are circumstances where solicitors are required to obtain more than or less than 15 CPD points by 31 October 2022 for the 2021/22 CPD/RME practice year. Paragraph 1(b) of the Statement is applicable to the following solicitors:

- (i) Where a solicitor held a practising certificate for part of the 2021/22 CPD practice year only; or
- (ii) Where a solicitor was granted a CPD suspension for the 2021/22 CPD practice year pursuant to rule 9 of the CPD Rules, or
- (iii) Where a solicitor resumed practice in Hong Kong in the 2021/22 CPD practice year from a CPD suspension and was required to make up the outstanding CPD points prior to his or her CPD suspension by 31 October 2022.

Note 2:

Paragraph 4 of the Statement is applicable to solicitors who have claimed CPD points under the deemed accreditation system.

Guideline 10 of the CPD Information Package provides that practitioners may claim up to 3 CPD points of the annual requirement of 15 CPD points by attending courses for which practitioners may self-accredit the courses without the need to apply to the Law Society for CPD accreditation on condition that the courses undertaken by them fall within the accreditation criteria set out in Guideline 10.3.

Where the annual requirement is pro-rated according to the CPD Information Package, practitioners may claim up to 1/5 of the pro-rated CPD requirement rounded down to the nearest half point under the deemed accreditation system.

Note 3:

Paragraph 7(i) of the Statement is applicable to solicitors who had practised outside Hong Kong for 75% or more within the 2021/22 RME practice year or who had practised in a Hong Kong law firm for less than 100 days in the 2021/22 RME practice year.

Paragraph 7(ii) of the Statement is applicable to those solicitors who were granted exemption from completing their RME requirement in the 2021/22 RME practice year under rule 8A of the RME Rules due to exceptional circumstances.

Paragraph 7(iii) of the Statement is applicable to in-house solicitors or solicitors who did not practise in a Hong Kong law firm for the entire 2021/22 RME practice year.
