

Junius K. Y. Ho President The Law Society of Hong Kong

Mr. Junius Ho was elected the President of the Law Society of Hong Kong on 26 May 2011. He will lead the 20-member Council which is the governing body of the Law Society of Hong Kong with immediate effect. Prior to becoming President of the Law Society, Mr. Ho had served in the Council of the Law Society of Hong Kong as a member since 1995 and was elected as Vice President since 2005 taking charge of practitioner's affairs and Mainland legal affairs.

Mr. Ho was admitted to practise as a solicitor in Hong Kong, Singapore and England and Wales in 1988, 1995 and 1997 respectively. He is the Senior Partner of Messrs. K.C. Ho & Fong, and Head of the firm's Litigation and Commercial Departments. He is also the Principal Representative of the Guangzhou Office of the firm. In 2003, Mr. Ho was appointed a China-Appointed Attesting Officer by the Ministry of Justice of PRC.

Apart from serving his own legal profession, Mr. Ho also serves various government and advisory boards, namely as Council member of Hong Kong Chamber of Commerce in China - Guangdong; Arbitrator of Wuhan International Arbitration Court and Zhengzhou Arbitration Commission; Consultant of Guangzhou Municipal Board for International Investment, Committee, Council member of Sir Wilson's Heritage Trust, Council member of Transport Advisory Committee of the Government of HKSAR, Committee member of Greater Pearl River Delta Business Council, Professional Services Advisory Committee and China Trade Advisory Committee of Hong Kong Trade Development Council, Chairman of Product Eco-responsibility Appeal Board Panel, and Rotated Chairman of Duty Lawyer Service Council (2005 and 2007).

Mr. Ho currently serves as Chairman of Tuen Mun Rural Committee, Ex Officio Member of Tuen Mun District Council, Ex Officio Executive Member of the 33rd Executive Committee of Heung Yee Kuk, and an Indigenous Village Representative of Leung Tin Tsuen in Tuen Mun.
