## **Debtor's Bankruptcy Petitions**

It has been noticed that in cases of debtor's bankruptcy petitions, the statement of affairs which is required to be filed with the petition is often incorrectly filled in resulting in the case being adjourned by the Court. As you no doubt appreciate, any unnecessary delay means wasting time and costs for all parties concerned.

I wish to take the opportunity in reminding members when dealing with bankruptcy cases, to observe and comply with the Bankruptcy Ordinance, the Bankruptcy Rules and the Court's Practice Directions that are issued from time to time. In particular, practitioners' attention should be drawn to the following:-

## (A) Statement of Affairs

- The statutory form should be adhered to. (a)
- The debtor's occupation and address should be provided. (b)
- List A: Secured Creditors (c)
- Value of property should be stated (Column 4).
- List B: Unsecured Creditors (d)
- a. Full detail of addresses of the creditors should be provided (Column 3).
- b. Amount the creditors says is owed (Column 4) & the amount the debtor thinks he owes (Column 5) should be stated.

(e) List C1: Assets

- a. Bank account number should be provided.
- b. The share of the bank account should be stated.
- (f) List E: Legal process outstanding:

Description and estimated value of any property seized (Column 4) should be provided.

- (g) List F: Income payments order
- a. Total amount paid under the order (Column 5) should be provided.
- b. Breakdown value should be specified.
- (h) List H: Statement of recent and: Each item should be completed. expected income

## (B) Debtor's Bankruptcy Petition

Petition should be attested by a solicitor or the Official Receiver or the Registrar in accordance with Rule 51 of the Bankruptcy Rules.

I would appreciate if you would bring this letter to the attention of your members.
