



EXPLANATORY NOTES TO THE SYMPOSIUM TOPICS

1. The WTO and Modernization of the Legal System

With China's accession to the WTO, the speed and scale of legal modernization have reached an unprecedented stage. Guided by the objective of transforming China into a country subject to the rule of law, and based on its practical situation. China will refer to foreign legal resources, gradually arrange the formation of a system of new concepts and rules of life which are adapted to the process of global legal modernization but with its own national features, to integrate the external and internal resources, and gradually modernize its legal system. This symposium will focus on the impact on a country's legal modernization of the entry into the WTO, the directions and objectives of the modernization of legal construction, and ways and means, as well as models for legal modernization.



2. Trade Services and the Legal Services Industry

The General Agreement on Trade Services (GATS) is the latest achievement resulting from the package agreements of the Uruguay Round. It is also the most important progress in a single field under the multilateral trade system. It expands for the first time the world recognized rules and commitments similar to the GATT, to a new international trade area, which is of huge dimension and has been developing quickly. Meanwhile, it should be noted that most of the trade services occur in the course of domestic economic activities, so its standardization from the very beginning will surely have an impact on domestic laws and regulations. Therefore, the General Agreement will surely restrict and influence on the laws and regulations related to commercial services (such as accounting and auditing, taxation services, architectural services, computer and related services, real estate services, advertising services, management consulting services, etc.), telecommunication services, distribution services, educational services, financial services (such as insurance, banking and other financial services), and transportation services. Participants are welcomed to conduct study and discussions on legislation, justice and legal services in the area of trade services.

3. The WTO and Internationalization of Legal Services

One of the commitments China made as a condition to WTO entry was to make progress in internationalizing its legal services industry. With the acceleration of China's economy integrating with the world economy, legal services have become more and more important. These have become very significant issues: how to honor the commitments to the WTO, how to develop the domestic legal services industry in the process of internationalization, as well as how the internationalization of the legal services shall better promote international trade and investment. The said topic will also include: opening-up and management of legal services market; its internationalization, specialization and dimension; its related international exchanges and cooperation; the internationalization of the legal services and talents competition in the global market; internationalization of legal services and the survival of the fittest of the legal services industry; the internationalization of legal services and the constitution of the legal services system; the role government plays in promoting and regulating the internationalization of the legal services market; etc.

4. The Function of Legal Services in WTO Dispute Settlement

WTO dispute settlement is an important mechanism for the WTO members to solve trade disputes among them. To study it, to be familiar and positively apply it will be necessary to effectively reduce trade disputes, eliminate trade barriers, and to protect WTO members' trade status and their economic interests. Dis-



cussions of this topic will include: the framework of WTO dispute settlement and its related rules; how legal services can provide efficient and useful assistance to the enterprises in disputes; the status and roles of governmental lawyers, lawyers in society and other legal service providers in the WTO disputes settlement; analysis of notable cases solved under the framework of the WTO dispute settlement, etc.

5. The WTO and Protection of Intellectual Property Rights

The Trade- Related Aspects of Intellectual Property Rights (TRIPS) Agreement is the most creative one among the results of the Uruguay Round. Its fundamental purpose is to provide sufficient and efficient protection to intellectual property rights. It includes the total seven component parts of intellectual property rights: copyright and adjoining rights, trademark rights, geographical indications, industrial design, patent rights, wiring diagram designs of integrated circuit, undisclosed secrets (including business secrets). In addition, protection of traditional intellectual property rights, protection of intellectual property rights of bio-diversity and intellectual property rights in the electronic commerce have attracted broad concerns as well. This symposium will introduce the international achievements in the protection of intellectual property rights in the aspect of legislation, law enforcement and justice, and invite joint discussion about how to strengthen legislation, justice and legal services in different countries so as to legally protect the lawful rights and interests of owners of intellectual property rights.

6. Improvement of the Legal Aid System

Legal aid is a system for a state to ensure that the weak and poor citizens have access to judicial resources and equal human rights. It is also an important social security mechanism. It is related to main and significant social matters, such as social justice and the protection of fundamental human rights. With China's accession to the WTO, the legal aid system needs further improvement, and must play its full role---contributing to the protection of legal rights and interests of the public as well as the maintenance of social justice. This symposium will provide you with a good chance to become acquainted with general information concerning the development situation of legal aid systems in various countries, and to discuss and exchange ideas about the opportunities and challenges brought about by accession to the WTO, to the legal aid development in different countries.

7. Alternative Dispute Resolution

In the past 20 or 30 years, in almost every country of the world, there has existed the common situation of too many civil and commercial cases, as well as minor



criminal cases, which has caused the problem of the overloading of cases and expensive litigation costs. Because of this, many countries have established an alternative dispute resolution system. The system in China, including administrative mediation and people's mediation, has played a positive role in practice. With the change of types and reform of judicial systems, there is an urgent need for all the countries to do research and exchange experience in the nature, mandatory procedure, and effectiveness of the agreement reached under the alternative dispute resolution mechanism, so as to learn from each other. During the symposium, participants will express their own ideas and share with each other results of their research.

8. Special Provisions in the WTO for Protecting the Developing Countries

The WTO provides to ensure that its members of developing countries, especially the least developed members can maintain their economic development level suitable to the need of the increase in their international trade amount, and also takes it as its aim. It demonstrates the result of negotiation achieved by the developing countries in the ten years of GATT, and marks the new international economic order that has been developing gradually in a more equal and reasonable direction. While the developing countries enjoy the same rights and share the same duties as the other member countries in the WTO, they have received some special treatment. For example, the protection degree could be a little higher than that of developed countries, and some other exceptional principles in the WTO. Participants are welcomed to express their opinions related to the features of their own countries, so as to make it more scientific and correct.

9. The WTO and the Training of High -Level , Foreign Related Legal Talents

With China's entry into the WTO, there is an urgent demand to train legal experts and lawyers, who are familiar with and can skillfully apply WTO rules to provide the state and enterprises with legal services, and can properly use the WTO disputes settlement rules to solve or avoid legal disputes that could occur at any time with more than 140 members, and guarantee that the protocol of China's accession to the WTO will be fully implemented. The participants will jointly discuss the characteristics and constitution of knowledge, skills and qualities of WTO related legal talents, ways and means to train special talents and their influence on the reform of legal education, strategy and practices for developing countries to train their high-level legal talents domestically, to develop international exchanges and cooperation to provide training and continual education to the high-level legal professionals.



VENUE FOR THE SYMPOSIUM

Location of the Symposium: Beijing

Beijing, the capital of China with a long history and splendid culture, is one of the most famous cultural and historical cities in the world. It was initially built up during the Ming Dynasty in 1421.

Now, around the city, magnificent Chinese architectures, elegant gardens and various former leading figures' residences are in harmony with modern towers, transportations and facilities, which significantly reflects new Beijing's unique, beautiful and grandiose features.





The Great Hall of the People

The opening ceremony of the symposium will be held at the Great Hall of the People. The Great Hall of the People, the venue for the National People's Congress (the Parliament) and the location for political and foreign activities of the States' leaders and people of China, is at the west wing of the Tiananmen Square. It has a big hall of conference with 76m in breadth and 60m in depth; a big banquet hall of more than 5000 seats and office building for the NPC are at its north and south wing separately.




inference Hall of the Kerry Centre Hotel, Beijing Outside Scene of the Kerry Centre Hotel, Beijing
