## LAW SOCIETY OF HONG KONG EDUCATIONAL TRUST

1. The objects for which the Law Society of Hong Kong Educational Trust ("the Trust") was set up include:
  - i) the provision of financial support to people who are residents of Hong Kong for furthering their study relating to the study of law and legal education in any Educational Establishment approved by the Trustees and to award such persons who are residents of Hong Kong scholarships, grants in maintenance and allowance to enable them to further their education whether in or outside Hong Kong;
  - ii) the promotion, organisation and provision of financial support to research projects, publications, seminars, conferences for the purpose of promoting the study of law and legal education and the importance of legal systems in Hong Kong; and
  - iii) The promotion, organisation and provision of financial support for any other educational and charitable activities related to the study of law and legal principles.
2. The Trustees are responsible for deciding how the Trust Fund ("the Fund") shall best be used and any decision by them shall be final and not subject to review.
3. The general intention of the Trust is to provide grants for single projects and not for those of a recurrent nature.
4. Applications to the Trust may be made by an individual, a group of persons or an institution. Awards made from the Fund will not be limited to lawyers but must be within the objects of the Trust.
5. In considering the merits of any application the Trustees will give consideration to the following matters but may, within their discretion, consider any other factors which they believe to be appropriate:
  - i) the proposed project ("the project") the subject of the application must be within the objects of the Trust;
  - ii) the benefit which such a project will have upon the development of the legal system and legal education in Hong Kong;
  - iii) the necessity for such a project to receive financial assistance;
  - iv) whether the project is feasible, practicable and desirable;
  - v) the suitability of the applicant to undertake the project;
  - vi) the length of time that it will take to complete the project;

6. Applications may be made at any time to the Trust and should be addressed to the Secretary General, The Law Society of Hong Kong, 3/F Wing On House, 71 Des Voeux Road, Central, Hong Kong and should be marked "Educational Trust Fund". Each application must contain a full description of the project and of the applicant and include the information as set out in paragraph 5 above. It will be for each applicant to satisfy the Trustees as to the matters contained in the said paragraph. The Trustees may require an applicant to provide further particulars or other information which will, in their opinion, assist them in considering the application. Applicants will be required to provide such authority or consent as the Trustees may require to enable them to make any enquiries concerning the project and the applicant that they may consider appropriate.
7. The amount and mode of payment of any grant shall be within the absolute discretion of the Trustees whose decision shall be final and not subject to review.
8. A grant of money from the Fund may only be used for the purposes of the project in respect of which the grant was made and no element of personal remuneration or monetary gain to the applicant will be permitted either directly or indirectly. A successful applicant will be required to provide the Trustees with a detailed account of expenditure at the completion of a project or at any stage during the project in respect of which a grant has been, or will be, made. The Trustees will monitor each project and may impose terms relating to the progress and conduct of the project.
9. In making any offer of a grant of money from the Fund the Trustees may impose a condition that any copyright in a project funded by the Trust shall be relinquished by the copyright owner so that the Trustees may within their unfettered discretion use it for whatever purposes they think fit.
10. Should a project remain uncompleted beyond a specified date for completion or within a reasonable time or if it has, in the opinion of the Trustees, been abandoned before completion, the Trustees may require the grantee of the monies from the Fund forthwith to repay any balance to the Fund and in such circumstances, if payment was to have been made in stages, to cease any further payments.
11. The Trustees may impose any terms or conditions which they consider appropriate in the particular circumstances for the prudent management of the Fund.
