PROGRAMME

Professional practitioners of law now have a profusion of electronic tools at their disposal. But it is still necessary to identify and master them both in terms of their use and in terms of the legal, ethical and material consequences of using them. Such constraints call for organizational measures (material safety and security, documentary and contractual control) combined with reflexes (onus of proof and incidents). Along with the acceleration in technology, legislative provisions enable the courts, public officers and the police to adapt to such evolution: *in terms of resources: computerization of services, formation of bodies such as the National Institute of Scientific Policing, introduction of a national file of genetic prints: *in terms of procedures: recognition of the evidential value of written documents and the electronic signature and eventually their validity, recognition of electronic archiving, liberalization of cryptology, using telecommunications in hearings, greater search and entry powers particularly by means of telematics and computers, furthering international cooperation. For electronic justice to be a permanent feature of the system, issues such as the formalism of legal procedures, protection of confidentiality, ethics and personal rights need to be resolved.

Afternoon: increases in capital, partial contribution of assets, restructuring, selling shares.
