Topic: "First Session of Foreign Capital in China Forum"

Foreign capital enterprises are mostly concerned about three aspects of basic environment in china: political environment, market environment and national encouragement policies. This forum is expecting to communicate and discuss the market admittance, management, foreign capital protection and promotion which foreign capital enterprises concern about, from the consistency, stability, expectation, and operation of policies point of view.

Recently, the State Council has delivered "Decision about investment system reformation". Thereinto, provisions about farther simplifying the approving program of investment items, enlarging the approving limit of provincial government, etc., will create more advantageous system environment for foreign businessmen investing in China, to which has been paid much attention by foreign capital enterprises.

The execution of "Management methods about foreign businessmen investing in the commerce field" and the normal open of commerce work utilizing foreign capital from experiment have showed the promises of retail when China entered into WTO, defined the region and schedule for commerce field opening to the outside world. At the same time with broadening market admittance, examination and approval procedure is simplified forward.

In addition, in order to facilitate enterprises to discuss deeply with responsible department of the government, we have arranged rap sessions about the most concerned aspects of foreign capital enterprises, such as energy field, electromechanical imports and exports, commercial field of circulation and information industry, which are expected to bring enterprises the greatest policy information benefits.

In a word, we hope sincerely that through the conference platform of this forum, delegates can obtain the newest policy information and communicate more deeply with government, at the same time offering the beneficial references of stratagem guide and enlarging investment for the enterprises. Hope the interested companies enter for enthusiastically.


