Professional Development Programme (Inbound)

During the period between November 2002 and October 2003, the Mainland Legal Affairs Committee arranged four inbound programmes for Mainland lawyers from the provinces of Anhui, Hubei, Guangdong and Shandong respectively. 12 Mainland lawyers from Anhui and Shandong, and 11 lawyers from Hubei and Guangdong were attached to Hong Kong law firms for a four-week secondment.

Due to the SARS outbreak, the number of inbound programmes arranged during the period was reduced.

During their secondment, the Mainland lawyers participated in a number of activities and visited various Government Departments. These included the Department of Justice, High Court, Hong Kong Exchanges and Clearing Limited, Land Registry, Company Registry, Legal Aid Department, Legislative Council, China Legal Service Hong Kong Ltd, Association of China-Appointed Attesting Officers Ltd., Hong Kong International Arbitration Centre, Faculty of Law of the University of Hong Kong and the Hong Kong Bar Association.

During some of these visits, the Secretary for Justice, the Deputy Solicitor General Mr. Stephen Wong, High Court Registrar Mr. Christopher Chan, Dean of the Faculty of Law of the University of Hong Kong Professor Johannes M.M. Chan and Dr. Fu Hualing also received the Mainland lawyers.

Professional Development Programme (Outbound)

An outbound programme for Hong Kong Solicitors was arranged to Sichuan for two weeks in August. It was the second exchange activity, after the four-week secondment of 12 Sichuan lawyers to Hong Kong law firms. As a reciprocal training, five solicitors also participated in a two-week outbound Professional Development Programme to Sichuan, Chengdu. These programmes provided good opportunities for Hong Kong solicitors to foster collaboration and establish professional links with Mainland firms and lawyers. Such networking and collaboration will be particularly effective with the implementation of CEPA in January 2004.
