- The Legal Practitioners (Amendment) Ordinance 1998 shall come 1. into operation on 30 June 2005.
- 2. From 30 June 2005, a notary public can only engage in practice as a notary public if he holds **EITHER** –
 - (a) a current practising certificate as a notary public issued by the Hong Kong Society of Notaries; **OR**
 - (b) a current practising certificate as a solicitor issued by The Law Society of Hong Kong and a current certificate of membership issued by the Hong Kong Society of Notaries.

The full requirements for practice are set out in the new section 40D of the Legal Practitioners Ordinance (Cap. 159).

3. This means that membership of the Hong Kong Society of Notaries is mandatory for notaries public who wish to engage in practice as a notary public.
