Speaker: *U.S. Supreme Court Justice Anthony Kennedy*

Topic: *Judicial Independence and the Rule of Law*

Justice Kennedy was appointed to the Supreme Court by then-President Ronald Reagan in 1988. Justice Kennedy has been effective at building bridges between the Court's conservatives and liberals. He has recently become an important part of the Court's growing centrist bloc. In his speech, Justice Kennedy will review the importance of an independent judiciary in a democracy and how rule of law impacts our everyday lives.

Justice Kennedy was appointed to the U.S. Court of Appeals for the Ninth Circuit in 1975. President Reagan nominated him as an Associate Justice of the Supreme Court, and he took his seat February 18, 1988.
