一、招标项目的基本情况

项目1 国家体育场



项目2 国家游泳中心

位于北京奥林匹克公园内,建筑面积约5万平方米。北京市人民政府筹集建设资金,招标确定项目经营公司,负责该项目的运营。招标代理机构为三峡国际招标有限责任公司。

项目3 会议中心

项目 5 北京五棵松文化体育中心



Project 2 National Swimming Center




