### **Maritime Services Traineeship Scheme – Legal**

I write to express our sincere gratitude for your esteemed Society's assistance in our formulation of the Maritime Services Traineeship Scheme – Legal ("the Scheme"), which is officially launched today under the Maritime and Aviation Training Fund ("MATF").

Maritime law is one of Hong Kong's highly competitive professional services in the international arena. Being the only common law jurisdiction within China, Hong Kong's unique advantages under "one country, two systems" are salient. To consolidate Hong Kong's status as an international maritime centre on the one hand and develop high value-added maritime legal services in Hong Kong for better integration into the country's development course on the other hand, we need farther more home-grown maritime lawyers to enhance the availability and quality of our maritime legal services.

Considering that training of a maritime lawyer is resource intensive, this Bureau sets up the Scheme with a view to incentivising legal firms and barristers with maritime business to provide bespoke traineeship for those who aspire to a career in maritime law. Only with the invaluable participation of your representative in the Working Group concerned that we can actualise the Scheme.

The Scheme offers a monthly subsidy of \$20,000 to successful applicants for providing practical training focusing in maritime areas to each legal trainee, subject to a cap of two trainees per applicant at any one time annually. Utilising subsidies from the MATF, law firms or barristers with maritime business are hoped to be better placed to offer more trainee positions as well as to enhance the remuneration package for recruiting more competitive trainees. Interested law firms or barristers are most welcome to apply under the Scheme by completing the Application Form (Form 1) and submitting it together with all necessary documents to the MATF Secretariat.
