**Bankruptcy and Companies Legislation**  
**(Miscellaneous Amendments) Ordinance 2023 (Commencement) Notice 2023**

Pursuant to section 1(3) of the Bankruptcy and Companies Legislation (Miscellaneous Amendments) Ordinance 2023 (“**the Ordinance**”), the Secretary for Financial Services and the Treasury, by a notice published in the Gazette on 20 October 2023 (“**the Commencement Notice**”), appoints **29 December 2023** for the commencement of the following provisions of the Ordinance:

- (a) sections 3, 4, 5, 8, 9, 15, 16, 17, 18 and 21 of Part 2; and
- (b) Part 3.

As stated in our earlier letter dated 12 July 2023, Part 2 of the Ordinance deals with amendments in the Bankruptcy Ordinance (Cap. 6) (“**the BO**”), the Companies (Winding Up and Miscellaneous Provisions) Ordinance (Cap. 32) (“**the CWUMPO**”) and their subsidiary legislation relating to the submission of certain documents to the Official Receiver by electronic means.

With the commencement of the selected provisions in Part 2, the Official Receiver will specify forms and requirements relating to the electronic submissions of the documents, including the following:

- Annual Statement of Earnings and Property Acquired under section 43A of the BO to be submitted to Official Receiver as the trustee; and
- Report on the investigation of the conduct of the bankrupt under section 86A of the BO.

The Official Receiver's Office will further provide details of the electronic submissions system via its website.

Part 3 of the Ordinance deals with amendments in the BO, the CWUMPO and their subsidiary legislation to (a) require various notices, orders or matters under the relevant provisions to be published or given in the specified means as provided in Schedule 4 to the BO and Schedule 27 to the CWUMPO respectively; and (b) remove the newspaper advertising requirements. At present, the Gazette is the only specified means in the two schedules. Annex 1 to this letter provides a summary of the relevant major amendments. There are also amendments to some of the prescribed forms under the Bankruptcy (Forms) Rules (Cap. 6B) and the appendix to the Companies (Winding-up) Rules (Cap. 32H).

The amendments in Part 3 however do not affect the power of the court to make orders on the publication of notices. Where appropriate, practitioners may wish to consider whether to adopt additional advertising to bring the relevant matters to the attention of the public, including consideration on the mode of publicity to be used, which can be electronic or web-based or by way of newspaper.

The remaining provisions in Part 2 are expected to commence in 2025. The Official Receiver will provide further information in due course.

**Major Changes to the Publication of Notices under Part 3 of the Bankruptcy and Companies Legislation**  
**(Miscellaneous Amendments) Ordinance 2023 (“the Ordinance”)**

IMPORTANT NOTE:

1. This Annex 1 is meant to facilitate the insolvency practitioners in understanding the major changes to the publication of notices consequential to the commencement of Part 3 of the Ordinance.
2. The users of Annex 1 are reminded to seek independent legal advice if in doubt of their legal position.

Abbreviations:

BO	means the Bankruptcy Ordinance (Cap. 6), after the commencement of Part 3 of the Ordinance;
BR	means the Bankruptcy Rules (Cap. 6A), after the commencement of Part 3 of the Ordinance;
CWUMPO	means the Companies (Winding Up and Miscellaneous Ordinance) (Cap. 32), after the commencement of Part 3 of the Ordinance; and
CWUR	means the Companies (Winding-up) Rules (Cap. 32H), after the commencement of Part 3 of the Ordinance.

Meaning of specified means:

“Specified means” has the meaning given under section 2A of the BO (newly introduced under section 28 of the Ordinance) and section 2C of the CWUMPO (newly introduced under section 56 of the Ordinance). Under these sections, the Secretary for Financial Services and the Treasury is empowered to publish a notice in the Gazette to specify a medium as set out in Schedule 4 to the BO and Schedule 27 to the CWUMPO respectively for the publication of the relevant notices. At present, the Gazette is the only specified medium under the two schedules.
