### **Introduction:**

This seminar will discuss specific issues arising for solicitors, barristers and inhouse counsel from Hong Kong's December 2022 reforms to permit outcome related fee structures for arbitration (ORFSA) and 2019 reforms to allow third party funding for arbitration (TPFA).

## Speakers for Opening Session



**Mr Clifford Tavares**

Principal Government Counsel, Legal Enhancement and Development Office, Department of Justice

Mr Clifford Tavares is a Principal Government Counsel of the Legal Enhancement and Development Office (LEAD Office) of the Department of Justice (DoJ) of the Hong Kong Special Administrative Region. Before his present post, Mr Tavares specialized in civil litigation, advising on public law, immigration, competition law, town planning, land and building matters. He also supervised work relating to the promotion and development of mediation and arbitration services of Hong Kong.

The LEAD Office assumes the role of the central policy unit of DoJ and assists the Secretary for Justice and the Deputy Secretary for Justice in formulating strategic plans and co-ordination for effective implementation of DoJ's policy initiatives. Mr Tavares currently heads the team in the LEAD Office that helps drive policy initiatives in promoting Hong Kong's legal and dispute resolution services locally and beyond, including in the Greater Bay Area. The major initiatives that Mr Tavares has been involved in include the biennial Mediation Week and "Mediate First" Pledge event, and the Investment Law and Investor-State Mediator Training series. He has recently assisted in the enactment of the Arbitration and Legal Practitioners Legislation (Outcome Related Fee Structures for Arbitration) (Amendment) Ordinance 2022. Mr Tavares is currently a member of the Judiciary's Working Party on Mediation, as well as a member of the Steering Committee on Mediation and the Advisory Committee on Promotion of Arbitration both chaired by the Secretary for Justice.



**Mr Rory McAlpine**

Chair of ICC Hong Kong Arbitration & ADR Committee

Rory McAlpine has been the head of Skadden's Asia Pacific International Arbitration Group for the last ten years and is based in Hong Kong. He is the chair of the ICC Hong Kong Arbitration Committee. He has handled arbitrations in LCIA, ICC, HKIAC, SIAC, CIETAC, LMAA and UNCITRAL. Rory has four decades of experience in dispute resolution and is one of the most senior disputes lawyers in Asia. He holds rights of audience in England and in Hong Kong. He acts for corporates and financial institutions in complex and multijurisdictional disputes. As well as arbitration, he handles international litigation and alternative dispute resolution. He was one of the very first law firm to appear in the High Court in England and has conducted dozens of hearings and trials in that jurisdiction and in Asia.

Between 2013 and 2018, Kathryn chaired the HKIAC appointments committee, and she has also served on HKIAC's rules, proceedings and finance committees.
