Distinguished Features of the Hong Kong Legal System

Introduce the legal bilingualism in Hong Kong and its unique feature as the sole common law jurisdiction within China. Highlighting the principles of the rule of law, sharing will be made on how the Hong Kong legal profession plays a crucial role as a 'super-connector' and 'super value-adder' between the East and the West and in supporting Hong Kong as a gateway to the Greater Bay Area.

Role and Potential Contribution of the Hong Kong Legal Sector

Discuss the pivotal role of Hong Kong legal sector in the overall development of the GBA, highlighting the synergies Hong Kong legal professionals could bring to the region through their expertise in dispute resolution and regulatory compliance. Success stories will be presented to demonstrate its impact made on regional integration and economic development.

Secretary-General Asian Academy of International Law

Dr Huang Jiefang is Zhou Gengsheng Chair Professor of Wuhan University, a member of the Council of the Academy of International Law and Global Governance of Wuhan University. Previously, he was the Director of Legal Affairs and External Relations Bureau of International Civil Aviation Organization (ICAO), a specialised agency of the United Nations; Dean of the Law School of Civil Aviation University of China; Vice President of the International Law Association (Canadian Branch); Senior Teaching Fellow at the Institute of Air and Space Law, McGill University, Canada; a guest lecturer and member of Doctoral Opposition Committee of the Institute of International Air and Space Law, Leiden University, the Netherlands. He has delivered lectures or presentations in more than 20 countries, representing ICAO in various UN meetings, serving as one of the three members of the ICAO Joint Advisory Appeals Board.

Mr José-Antonio Maurellet SC is the Chairman of the Hong Kong Bar Association. He was called to the Hong Kong Bar in 2000 and to the Inner Bar in 2016. He was admitted in 2020 as a solicitor of the Eastern Caribbean Supreme Court, British Virgin Islands circuit. He is also a registered foreign lawyer with rights of audience in the Singapore International Commercial Court. He has sat as a Deputy High Court Judge for periods between 2018 and 2021, and has been appointed as a Recorder of the Court of First Instance since October 2021. He has advised and acted in numerous shareholder disputes, winding up petitions, and applications arising out of liquidations of companies (e.g. applications for provisional liquidators, receivers, validation orders, private examinations, unfair preference proceedings). José is a member as well as the board of directors of the International Insolvency Institute. He has also dealt with director disqualification proceedings commenced by the Official Receiver and the Securities and Futures Commission.
