Claims to monies held in any bank accounts of Messrs. Wong, Fung & Co.

NOTES

- 1. As the Council of the Law Society of Hong Kong (the "**Council**") had reason to suspect dishonesty on the part of a former clerk of Messrs. Wong, Fung & Co. (the "**Intervened Firm**") for misappropriation of client's money and was satisfied that the Intervened Firm had committed serious breaches of the Solicitors' Accounts Rules (Cap. 159F), the Council had no alternative but to exercise its powers to intervene into the practice of the Intervened Firm under Sections 26A(1)(a)(ii) and 26A(1)(c) of the Legal Practitioners Ordinance (Cap. 159) on 24 December 2020 to protect the interests of the public and the clients of the Intervened Firm.
- The Council appointed Messrs. Chui And Lau Solicitors as the intervention agent ("the Intervention Agent") and retained Messrs. Cheung Tong & Rosa Solicitors, Messrs. Kevin Ng & Co., Solicitors, Messrs. P.C. Woo & Co., Messrs. Robertsons and Messrs. Vincent T.K. Cheung, Yap & Co. (collectively, the "Five Firms") to assist the Intervention Agent.
- 3. If you wish to assert a claim to monies held in any bank accounts of the Intervened Firm (collectively, the "**Bank Accounts**"), you (which, if more than one claimant, shall apply to all the joint claimants) should:
 - a. complete the statement of truth; and
 - b. make a declaration in accordance with the enclosed declaration form before a commissioner for oaths.
- 4. After you have taken the steps in paragraph 3 above, you should send the following documents by post to **P.O. Box 247, General Post Office, Hong Kong**:
 - a. completed statement of truth and declaration form;
 - b. copy of all bank records and cheque etc. regarding your deposit into the Bank Account(s);
 - c. copy of bills, receipts and all documents relating to revenue and expenditure issued by the Intervened Firm to you;
 - d. copy of your identity card/passport;
 - e. if a claim is asserted on behalf of a company, you should also provide:
 - (i) copy of certificate of incorporation (and, where applicable, the certificate of change of name);
 - (ii) copy of business registration certificate;
 - (iii) copy of the latest Annual Return (Form NAR1) (and, where applicable, any subsequent Notice of Change of Company Secretary and Director (Appointment/Cessation) (Form ND2A));
 - (iv) printout of the document index search page in respect of the company on the website of the Companies Registry Cyber Search Centre (www.icris.cr.gov.hk);

- (v) certified copy of board resolution regarding the appointment of authorised person for making the relevant claim; and
- (vi) copy of identity card/passport of the authorised person.
- 5. The Council has appointed Messrs. Deacons ("**Deacons**") to assist the Intervention Agent to collect the statement of truth and declaration forms and conduct a preliminary review of the collected forms.
- 6. Please note that the Intervention Agent/the Five Firms/Deacons cannot complete the statement of truth and/or administer the execution of the declaration form for you. You are hereby advised to seek legal advice where appropriate.
- 7. Deacons will issue you an acknowledgement of receipt of your statement of truth and declaration form. Deacons will also contact you if your statement of truth and declaration form is incomplete. If you have not received an acknowledgment of receipt after 7 days from the date of dispatch of your statement of truth and declaration form, you may contact Deacons by the following ways:-

- 8. In due course, the Intervention Agent/the Five Firms will conduct a detailed review of the statement of truth and declaration form sent by you in order to verify your claim. Upon being notified in writing by the Intervention Agent/the Five Firms ("**Proof of Claim**"), you or your duly appointed solicitor shall attend and prove your claim at such time, place and manner as shall be specified in the Proof of Claim or in default thereof, you will be excluded from the benefit of any distribution of monies held in the Bank Accounts.
- 9. For the avoidance of doubt, it should be noted that you may not be able to recover your money even after having complied with the procedures as stated in this note or any Proof of Claim if the Intervention Agent/the Five Firms do not accept your claim. Even if the Intervention Agent/the Five Firms has/have verified your claim and accepted your claim, you may still not be able to recover your money claimed in full. The amount of money to be distributed to you will depend on the number of claimants and the total amount of money kept in the Bank Accounts of the Intervened Firm. A court order will be obtained before any distribution of money is made.
- 10. It takes time for a claim to be verified and for a court order to be obtained, the Intervention Agent/the Five Firms will contact you after the verification of claims and the making of the relevant court order.
