He will lead the 20-member Council which is the governing body of the Law Society of Hong Kong. He is a partner of the law firm Milbank, Tweed, Hadley & McCloy.

Additionally, <u>Ambrose Lam</u> has been re-elected as one of two Vice-Presidents, and <u>Stephen Hung</u> has been elected Vice-President.

Mr Yih joined the Council of the Law Society of Hong Kong in 2003 and has been Vice-President since 2009. He currently chairs the Law Society's Standing Committee on Standards and Development and the Legal Education Committee. He has keen interests in maintaining the highest standards for the profession and the education and career of young lawyers.
