**Statement from President of The Law Society of Hong Kong on  
Report of Suspicious Parcel Received by the High Court**

I note from media reports that the High Court received a suspicious parcel on 5 July 2022.

I strongly condemn all acts of intimidation against the judiciary. Intimidation against judicial officers is not only a serious criminal offence, but also a threat to the rule of law and judicial independence, which are cornerstones of our society.

Article 85 of the Basic Law provides that the courts of Hong Kong shall exercise judicial power independently, free from any interference. I urge all parties to respect the rule of law and safeguard the dignity of the court.
